Upon signing the proposal we are prepared to start work immediately.

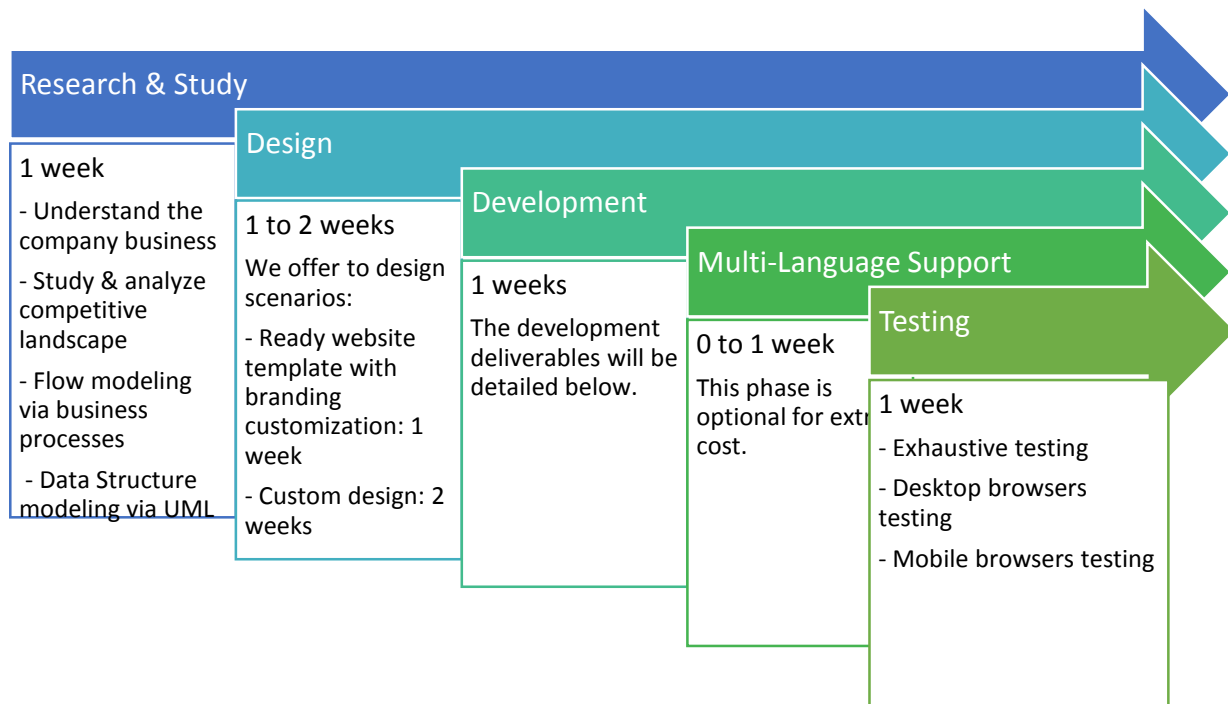


Figure 1. Project Timeline

Research & Study

Development

ADHENE adopts the agile and iterative development process and the test-driven approach. This methodology focuses on delivering Value to the customer as fast as possible with minimum time waste and changes impact by dividing the project into many functional and tested deliverables ready for the end user.

We use Java as server side programming language; HTML5, CSS3 and JQUERY as client side.

Testing

Our QA department will test the site across different browsers (Firefox, Chrome, Safari, and Internet Explorer 9+) and mobile devices (iOS, android smartphones and tablets). Any bugs that arise from this testing will be fixed prior to launch.

Confidentiality

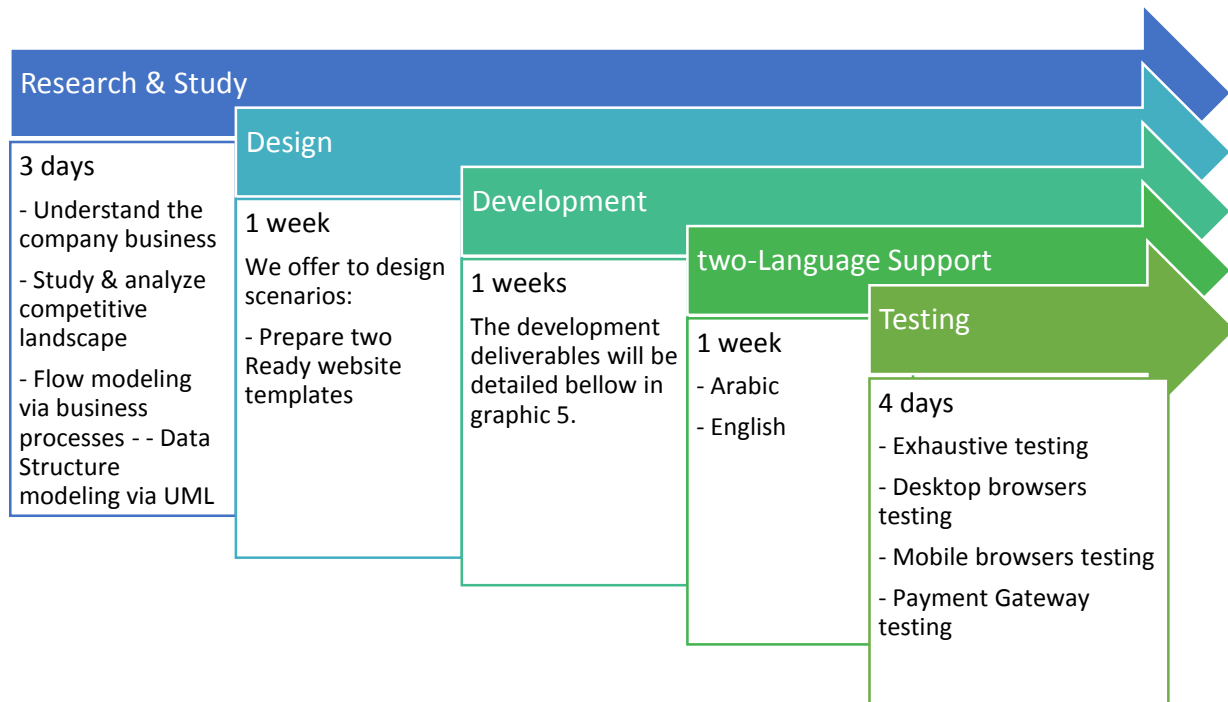
